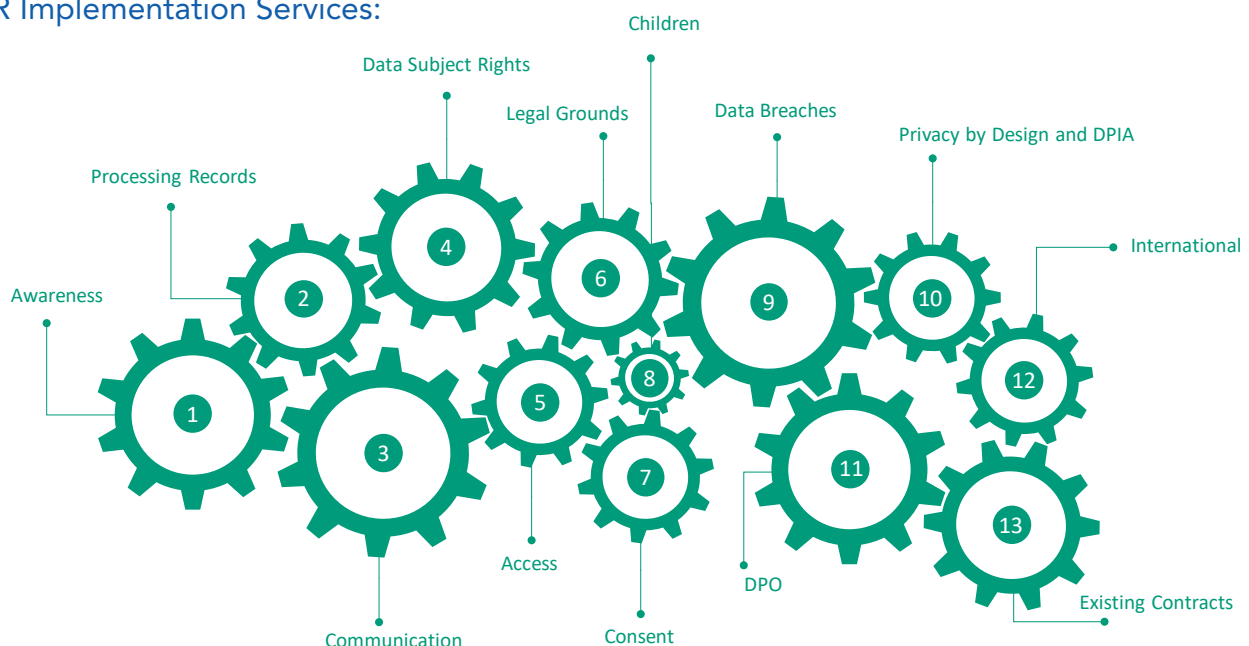

A Privacy Compliance assessment is an important service that will answer all your questions concerning the state of GDPR compliance in your organization and will provide a hands-on roadmap for remediation.

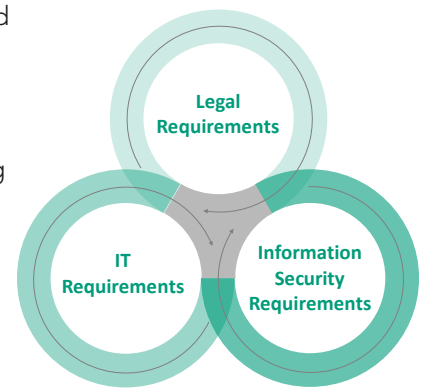
GDPR Implementation Services:
